MEMORANDUM OF UNDERSTANDING

FOR THE DEVELOPMENT OF ACADEMIC COOPERATION

The general objective of this Memorandum of Understanding (MoU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and cultural development on both institutions, and to contribution to increased academic cooperation. Thus

1. The two Educational Institutions will:

- a) cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests;
- b) endeavour to encourage students and staff to spend periods of time in the host institution. The exchange of students will be dependent on the execution of a formal Student Exchange Agreement prior to commencement of this activity;
- c) promote higher secondary students for the university graduation through the college under this MoU, as mutually agreed in writing between the parties prior to commencement of this activity:

2. The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both institutions.
3. Academic members of staff and other personnel of one partner institution may spend periods not normally exceeding one academic year in the other partner institution. In supporting such an arrangement, the home institution undertakes to continue the salary of the participant.
4. The host institution agrees to assist in the seeking of appropriate housing, and to supply work space, library and technical facilities as appropriate.

Purpose

The main purpose of this MoU is to utilize the expertise of both parties in sensitizing social issues with special focus on academic activities

Funding

This MoU give no commitment for financial obligations between two parties. And that this is meant for only sensitising students on social issues and to make available them for meeting the requirement of two parties on as service basis.

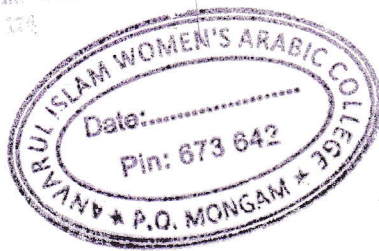
Duration

This MoU would come into effect on the date of signing and would be in effect for a period of **Four Years**. This MoU will be valid until it is expressly terminated by either party on mutually agreed terms. Both parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.
