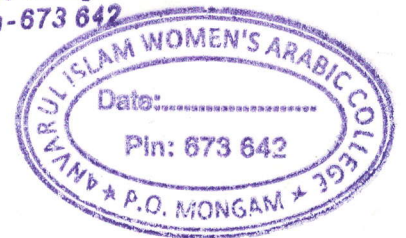

Co- operation shall be carried out through such activities as:

1. Faculty and Student exchange in mutually interest fields/academic collaborations and transfer of knowledge.
2. Students and teachers involvement in academic activities like seminars, workshops, trainings etc.
3. Sharing library facilities for use between faculties and students of two institutions.

TERMS OF IMPLEMENTATION, REWEWAL, REVISION

2. This MoU becomes effective on the day it is signed and will remain valid for 2 years
3. This MoU can be renewed/terminated prior to 60 days notification period of the validity period and should be discussed and agreed by both parties.

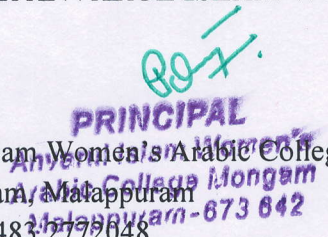
